Proposals are being requested for furnishing all materials, and performing all work necessary to complete the replacement of two boilers and related piping - South Building at the Miami Valley CTC, Clayton, Ohio, in accordance with drawings and specifications prepared for the same by the Office of the Superintendent for the Miami Valley CTC School District.

WORK DESCRIPTION: Selective demolition, plumbing, mechanical, and electrical work.
